

- 2. Student Representative Report Ms. Abigael Weit
  - Bonfield On May 12th, the 5th grade as Watershed Day and the Elementary Orchestra Concert will be held at 7 pm. On the 13th, the Kindergarten classes will travel to the Eastland Alpaca Farm. The Brush, Brush Smile varnish program will be held in the morning that day as well. May 15th Bonfield will have their Track and Field Day for the 6th graders. The 18th of May 5th grade students will have a field trip to Philadelphia. The JRB Open House will be at 6:30 pm on May 19th. The elementary band concert will be held at 7 pm at the WHS on the 21st. The next day, the Bike Rodeo will be held. Lastly, fine arts day will be on the 28th of May.
  - Kissel Hill Students in grades 3rd through 6th completed their state standardized testing during the month of April successfully. The school has been focusing on the ideas "an opportunity to show growth" and confidence in oneself" throughout the testing. Students worked on engaging in tasks with their full attention and reflecting on personal growth made since the beginning of the year. The beginning of May brought four rounds of assessments for kindergartens that brought parents from all four schools to ensure the "just right learning" policy was for every student. Later in May, there will be one more round of Dibels Assessments, CDTs for grades 3-6, and the GRADE assessment for students in kindergarten through 3rd grade. Kissel Hill's race for education will be held May 27th.
  - Middle School A volleyball tournament and a teacher dress down day enabled the council to donate \$1,080.00 to the Leukemia and Lymphoma Society. Student Council also held a dance and dodgeball tournament to help raise money for the high school's mini-thon program and ended up donating \$1,200.00 to that cause. At the end of April, to celebrate the end of PSSA testing, Student Council held three Spirit Days. Everyone had a lot of fun dressing up for Twin Day, Generation Day, and Sports Team Day. Student Council is gearing up for Team Face-off, a field-day event that will be held at the end of the year. Members of Student Council are busy making posters and distributing different colored bandanas to members of each grade level team. The 8th grade class will also be holding their first elections to choose Class Officers and Student Council members for their 9th grade year.

#### 1. Welcome and Public Comment

#### 2. Facilities Use Rates Proposal

Mrs. Kramer explained that every three years we examine our fee structure. Classifications of facility users are included in Board Policy and reviewed as part of the process. A draft handout was provided for the Schedule of Fees, outlining current rates and the proposed changes. Classifications, a proposed schedule of fees, personnel rates, and equipment rentals were shared by Mrs, Kramer. Comparisons to similar districts were also examined. The different class groups were explained and examples were provided. Groups B, C, and D all require proof of insurance. Class B groups affect community groups. Mrs. Kramer also shared the proposed increases in rates and rationale as related to specific facilities, fields, etc.

#### 3. 2015-16 Cafeteria Budget Presentation and Recommendation

Mrs. Karen Miller presented information regarding several pricing options for the 2015/2016 school year. Typically when prices increase, participation decreases. The impact of this decrease in participation was discussed. Mrs. Miller discussed government regulations, operation expenses, personnel costs, potential expenses with regards to equipment and the impact on the Food Services Budget. Mrs. Miller recommended that the prices for breakfasts and lunches remain the same. A history of lunch prices and participation was also presented. The results from a Meal Price Survey comparing our lunch prices to other local districts was also shared.

#### 4. 2015-16 Lancaster County Academy Budget

Mr. Wertsch shared that the district is planning on exiting the Lancaster County Academy Program for the 2016-2017 school year, which in the past has provided WSD ten slots in their program. Fewer and fewer students have utilized this program in the past several years, due to other options which are now available.

\*The committee reviewed the proposed 2015-2016 and recommends approval.

#### 5. 2015-16 General Fund Budget Updates

To date the State has still not provided school districts with information regarding the State Budget. Mr. Wertsch continues to monitor trending. Health care expenses continue to rise. The district will realize savings related to personnel going inot next year, as well as , anticipates increases in EIT revenue.
