1. Budget Preview

~ Mr. Nathan Wertsch, Chief Financial Officer

Mr. Wertsch provided a budget update. He pointed out that there has been no tax increase for three years. He shared our millage rate in comparison with the Lancaster County average. He discussed the proposed budget with no tax increase. He shared information regarding the State Property Tax Reduction Allocation and the notable increase. Mr. Wertsch also provided a review of the current 2022-2023 budget related to local, state, and federal revenues and expenses. He shared a three-year projection. He discussed the major expense variables — charter payments and health insurance. Mr. Wertsch pointed out major state budget proposal variables that are still unknown with regards to basic ed and special ed subsidies. A recommendation to approve the Proposed Final Budget with no tax increase will be taken to the Board for approval at the May 17<sup>th</sup> Board Meeting.

### 2. Interviews for Vacant Board Seat

Questions related to the following were asked: what each candidate has to offer as a member of the School Board, previous committee experience, team collaboration and working with others who have differing views, current challenges facing school boards, and questions they were expecting to be asked. Mr. Rucci thanked the candidates for their interest in serving on the School Board.

### **MINUTES**

#### 1. Welcome and Public Comment

Mr. Wertsch welcomed everyone to the May meeting. There were no comments for the good of the group.

#### 2. 2022-23 Proposed Final General Fund Budget

Mr. Wertsch provided a Budget Update. Mr. Wertsch began with where we left off in March, in a good place. He then updated on where we are now, proposed to be balanced with no tax increase. Mr. Wertsch also shared State property tax reduction allocation went up from the 21-22 actual to the 22-23 preliminary.

Mr. Wertsch transitioned to providing the committee an overview of the 2022-2023 budget. He shared that we are finally starting to see interest rates increasing. Mr. Wertsch reminded the committee that a majority of our budget comes from salary and benefits. We are at a balanced budget of just under \$80 million.

Mr. Wertsch provided a three-year budget projection showing revenue and expenses along with a potential tax impact in 2022-2023. Mr. Wertsch discussed a major expense variable update. We are now over 1.9 million for cyber charter payments as of May. The other item noted was Health Insurance expenses as the district is self-funded. Mr. Wertsch shared Major state budget proposal variables that are still unknown: Basic ed subsidy and Special Ed Subsidy along with Charter School Reform potential savings.

Lastly, Mr. Wertsch shared next steps - May 17th board meeting - recommend to approve Proposed Final Budget with no tax increase.
